Details of all Specific national or local scheme/intervention(s) available	<p>South Lanarkshire Council (SLC) provide this service for males across North and South Lanarkshire and females residing in North Lanarkshire are managed by the Women's Service.</p> <p>Support and interventions include support with any immediate needs such as benefits, housing, keep well health check and depending on identified risks and needs, women have access to the interventions and programmes listed below.</p>
Possible Outcomes	Increased opportunity to address any immediate needs including housing, health, benefits and support, engagement with justice team in preparation of completing Community Justice Social Work Report and potential community disposal.
Process for Assessment and/or inclusion in scheme/intervention	South Lanarkshire Council (SLC) social work court team undertake assessment.

Programme Title and Provider	Unpaid Work

<p>Details of all Specific national or local scheme/intervention(s) available</p>	<p>Wood workshop: individuals learn the safe use and storage of hand and electrical tools, health and safety in a workshop environment and general joinery skills. Items made are used to improve school playground and other community areas. Suitable for males and females – if aged under 18 years, a supervision requirement must be imposed.</p> <p>Home improvement workshop – individuals learn skills such as surface preparation, painting, decorating, plastering, tiling and mono-blocking and subsequently decorate community facilities. Suitable for males and females – if aged under 18 years, a supervision requirement must be imposed.</p> <p>Laundry workshop: collection, sorting and laundering of clothing which are returned to charity shops. Laundering of recycled school uniforms and returned to local charities and family centres. Suitable for males and females. If aged under 18 years, a supervision requirement must be imposed.</p> <p>Craft and sewing workshop - hand and safe use of sewing and embroidery machines whereby soft furnishings are donated to families in need and craft items made being sold at fayres with proceeds donated to local charities. Suitable for males and females - if aged under 18 years, a supervision requirement must be imposed. This may be suitable for individuals requiring lighter duties.</p>
	<p>Bicycle workshop – repair and maintenance of discarded bicycles which are subsequently donated to local schools, low income families and NLC toy appeal. Suitable for males and females - if aged under 18 years, a supervision requirement must be imposed.</p> <p>General squad - individuals participate in a range of environmental projects such as ground clearance, landscaping, renovation and construction of play areas, garden refurbishment and canal restoration. Suitable for males and females - if aged under 18 years, a supervision requirement must be imposed. Suitability may depend on the individual's health and mobility factors.</p> <p>Allotment and market garden - individuals learn skills in soil preparation, husbandry, planting and bringing on from seed a variety of flowers, fruit and vegetables. Goods harvested are donated to children's units and sheltered housing complexes.</p>
<p>Possible Outcomes</p>	<p>Reparation to the community. Work skill and soft skill enhancement, prosocial identity. Opportunity to engage in generative activities.</p>
<p>Process for Assessment and/or inclusion in scheme/intervention</p>	<p>Criminal Justice Social Work report stage and post sentence interview, whereby the individual's circumstances, risks, skills and interests are taken into account.</p>

Programme Title and Provider	Unpaid Work – Youth Justice
Details of all Specific national or local scheme/intervention(s) available	Young people will be supported by the Restorative Justice Team and a programme of work will be developed on an individual basis. The young people could be placed in a work squad in the community, in an individual placement or in one of the three workshops which provide skills in home improvements, woodwork and a bike repair.
Possible Outcomes	The young person may have a feeling of achievement having completed their placement and may feel a gain a sense of structured in their routine. They may also gain skills from their placement, workshop or educational element which they can gains hours for attending.
Process for Assessment and/or inclusion in scheme/intervention	Through the Criminal Justice Social Work Report. Assessment of the placement would be completed by the Restorative Justice team once an Order had been made by the Court.

Details of all Specific national or local scheme/intervention(s) available	Predominantly provided by external agencies, individuals are involved in groundwork and gardening, assisting in charity shops and community cafes.
Possible Outcomes	Reparation to the community. Work skill and soft skill enhancement, prosocial identity. Individuals may continue with individual placement as a volunteer when unpaid work ends or other generative activities.
Process for Assessment and/or inclusion in scheme/intervention	Criminal Justice Social Work report stage and post sentence interview, whereby the individual's circumstances, risks, skills and interests are taken into account. Risk assessment of the placement agency to discuss health and safety requirements, responsibilities, eligibility criteria and exclusions.

Programme Title and Provider	Other activity
Details of all Specific national or local scheme/intervention(s) available	Individuals can access the interventions provided by third sector partners detailed below. In addition, justice social work provide interventions to address specific behaviours (alcohol/drug use, employment, leisure), relationships (family work, Solihull parenting programme), pro-criminal attitudes and behaviours (anger, impulsivity) and responsivity issues. A number of 'other activity' activities provided by partner agencies such as Harm Reduction, British Red Cross, Scottish Association for Mental Health (SAMH), Routes To Work are certificated.

Programme Title and Provider	Supervision

<p>Details of all Specific national or local scheme/intervention(s) available</p>	<p>Each individual subject to supervision has an allocated case manager who plans, manages, reviews and evaluates supervision. The case manager directly provides support, supports engagement with other services and assists the person to build their capacity and opportunity to change. Interventions address specific behaviours such as:</p> <ul style="list-style-type: none"> • Alcohol/drug use and include alcohol brief intervention, relapse prevention or referral to Addiction Recovery Team for specialist pharmacological or psychosocial interventions. • Leisure/recreation whereby the individual is supported to engage in prosocial activities. • Employment / education such as support from Remploy, Routes To Work, Venture Trust. • Interventions to address relationships/parenting include Solihull parenting programme, communication skills and family work. • Interventions to address pro-criminal attitudes and behaviour include anger management, impulsivity, self-control, victim awareness and core cognitive and behavioural skills. • Interventions and support also target identified needs such as health, housing, debt and responsivity issues such as motivation, denial and learning style.
<p>Possible Outcomes</p>	<p>Depending on the identified needs/risks and support/intervention provided to address needs/risks, possible outcomes include:</p> <ul style="list-style-type: none"> • Accommodation is obtained and sustained. • Employability skills enhanced and improved opportunities to access education, training, employment, volunteering. • Debt reduced, money management. • Improved ability to identify triggers and skills and strategies to respond to challenging situations. • Engagement in prosocial supports and activities Improved coping skills and strategies. • Improved family relationships/parenting and safe personal relationships. • Reduced alcohol or drug use. • Increased motivation and belief in behaviour change.
<p>Process for Assessment and/or inclusion in scheme/intervention</p>	<p>Criminal Justice Social Work report identifies initial case management plan to address identified risks, needs, strengths and stage of change. This is expanded on in the initial stage of supervision and regularly reviewed and evaluated.</p>
<p>Where a specific service / intervention is not available, is there capacity to provide a bespoke service based on Judicial request?</p>	<p>Each person coming through the justice system will be assessed as an individual to identify their specific needs and risks. If an intervention programme is not available, the case manager will undertake work with the individual to address their behaviour to reduce the likelihood of further offending.</p>

Interventions suitable for	Young People
Programme Title and Provider	Supervision – Youth Justice
Details of all Specific national or local scheme/intervention(s) available	<p>The Court must impose a supervision requirement if the young person is under the age of 18 years old.</p> <p>Young people can be supervised by either the Children and Families Team, the Women Offender Service or a Justice Team depending on whether they are already an open case to Children and Families or not.</p> <p>Young females not currently allocated a Children and Families worker would be supported by that Women Offenders Service. Young people at risk of custody or secure accommodation may also be provided with support from intensive services which operates seven days a week and in the evenings.</p> <p>The Supervising Officer would be expected to use the principles of the Whole System Approach when supervising young people.</p>
Possible Outcomes	<p>The young person will be given support by the most relevant supervising officer help them address their offending, behaviour and reduce their offending behaviour.</p> <p>Support should also assist the young person with non-criminogenic needs to create stability in their lives which will in the longer term reduce their risk of further offending, e.g. assisting with stable housing, addressing addiction, gaining employment or finding an educational placement.</p>
Process for Assessment and/or inclusion in scheme/intervention	Through the Criminal Justice Social Work Report. Referrals to intensive services would be made by the allocated Social Work who is supervising the Community Payback Order.
Where a specific service / intervention is not available, is there capacity to provide a bespoke service based on Judicial request?	Each young person coming through the criminal justice system will be assessed on an individual basis to identify their needs and risks. If a programme is not available, the case manager will undertake work on an individual basis to reduce the likelihood of further offending.

Programme Title and Provider	Moving forward, making changes

Details of all Specific national or local scheme/intervention(s) available	Moving forward, making changes - behavioural programme delivered in modules, allowing the programme to be tailored to the individual's specific needs and circumstances. Programme is for adult males convicted of sexual offences or offences with a sexual element.
Possible Outcomes	Attitude and behaviour change, improved self-management
Process for Assessment and/or inclusion in scheme/intervention	Criminal Justice Social Work report and requires SA07 risk assessment. Screening panel considers suitability.

Interventions suitable for	Males and Females from aged 16+
Programme Title and Provider	UP2U : Creating Healthy Relationships
Details of all Specific national or local scheme/intervention(s) available	<p>UP2U is a domestic abuse intervention programme which is delivered to individuals who are subject to a Community Payback Order or Licence as a result of a domestic abuse offence.</p> <p>This is an assessment led intervention and UP2U treatment plans are devised in relation to the individuals risk and need, therefore completion of the programme will vary from 6 sessions to 40 sessions.</p> <p>A voluntary partner support service will also be offered to any partner and/or ex-partner of the individual undertaking the UP2U programme.</p>
Possible Outcomes	<p>UP2U is a behaviour change programme that aims to break the cycle of an individuals need to use abusive behaviours in their relationships, in particular their intimate relationships.</p> <p>Programme methods support the individual to manage emotions using positive self-talk and mindfulness techniques to interrupt negative coping strategies. UP2U participants will be supported to take responsibility for their behaviours and increase victim empathy and understanding of the impact of domestic abuse on others.</p> <p>The desired outcome is to support the individual to develop healthier relationship behaviours and to work with partner agencies to maximise safety and wellbeing of the individual's partner's and/or children during the behaviour change period.</p>
Process for Assessment and/or inclusion in scheme/intervention	<p>The supervising social worker will complete Module 1 – Assessment and Engagement, which is a 4 session module completed within the first 3 months of the order/licence being imposed.</p> <p>The aim of this module is to work with any resistance shown to try and shift attitudinal views so that the individual is more accepting of their unhealthy relationship behaviours and their willingness to engage and change is increased. If this is achieved, then this would deem the individual suitable to continue onto Module 2 of the programme. The programme can be delivered on a 1:1, 2:1 or groupwork basis</p>

Interventions suitable for	Young people
Programme Title and Provider	Youth justice
Details of all Specific national or local scheme/intervention(s) available	Young people can be required to attend a number of programmes as part of their Community Payback Order including the Road Traffic Offenders Group, Better Lives programme and Moving Forward Making Changes programme as well programmes delivered by intensive services.
Possible Outcomes	The young person will address their specific offending behaviour in a group work setting. Assisting them to consider the consequences of their behaviour and in turn hopefully reducing their likelihood of recidivism.
Process for Assessment and/or inclusion in scheme/intervention	Through the Criminal Justice Social Work Report and assessment by the group facilitators.

Interventions suitable for	Adults
Programme Title and Provider	Treatment: mental health
Details of all Specific national or local scheme/intervention(s) available	<p>Treatment includes inpatient or outpatient and includes pharmacological and psychosocial interventions provided by psychology, psychiatry and community mental health teams.</p> <p>The individual requires to suffer from a mental condition, compulsory treatment or compulsion order is not required, proposed treatment is appropriate and arrangements are in place for provision of treatment. A supervision requirement must be imposed.</p>
Possible Outcomes	Improved mental health, emotional management, improved coping skills and strategies, improved resilience, increased compliance with medication/treatment.
Process for Assessment and/or inclusion in scheme/intervention	At Criminal Justice Social Work report stage. A psychiatric or multidisciplinary assessment may be requested at this stage. Specialist assessment is required.

Interventions suitable for	Young People
Programme Title and Provider	Treatment: Mental Health; Youth Justice
Details of all Specific national or local scheme/intervention(s) available	<p>A young person could be required to attend for Mental Health treatment as part of their Community Payback Order.</p> <p>The young person must agree to the mental health treatment requirement otherwise the requirement cannot be made.</p>
Possible Outcomes	The young person will address their mental health issues which may assist in the reduction of offending and ensure they get adequate support.

Process for Assessment and/or inclusion in scheme/intervention	Through the Criminal Justice Social Work Report, where the specific need is identified in the Criminal Justice Social Work Report. This option would require clear evidence of a mental health condition.

Interventions suitable for	Adults
Programme Title and Provider	Treatment: drugs
Details of all Specific national or local scheme/intervention(s) available	Interventions provided by case manager or specialist services may include motivational enhancement, relapse prevention, trauma counselling and support provided by Building Futures detailed below. The individual experiences difficulty with drug misuse however a chronic drug dependency is not established. A supervision requirement must be imposed.
Possible Outcomes	Substance use is reduced or stopped and drug related offending decreased. Improved ability to manage high risk-situations, ability to identify triggers and develop coping strategies. Improved physical and emotional health.
Process for Assessment and/or inclusion in scheme/intervention	At Criminal Justice Social Work report stage. Support and interventions may be provided as part of supervision requirement.

Interventions suitable for	Young People
Programme Title and Provider	Treatment: Drugs; Youth Justice
Details of all Specific national or local scheme/intervention(s) available	Young People can be required to attend drug treatment as part of their Community Payback Orders. This service would be provided by North Lanarkshire Integrated Addiction Services.
Possible Outcomes	The young person will address their addiction which would hopefully assist in the reduction of offending and them to gaining a more stable lifestyle.
Process for Assessment and/or inclusion in scheme/intervention	Through the Criminal Justice Social Work Report, where the specific need is identified in the Criminal Justice Social Work Report.

Interventions suitable for	Adults living in North Lanarkshire who could benefit from one to one support to progress towards a life free from addiction and mental health struggles.
Programme Title and Provider	The Breakthrough service is provided by Blue Triangle in partnership with North Lanarkshire's Alcohol and Drug Partnership and the CORRA Foundation.

Details of all Specific national or local scheme/intervention(s) available	<p>Breakthrough is an innovative service provided by Blue Triangle, delivering a trauma informed, person centred approach to supporting individuals throughout their recovery journey.</p> <p>The Breakthrough service provides direct support and engagement in a connected community model to empower people to unlock their full potential.</p>
Possible Outcomes	<p>Reduced impact of addiction issues / mental ill health.</p> <p>Promote and sustain recovery.</p>
Process for Assessment and/or inclusion in scheme/intervention	<p>Direct referral to service provider, by phone or e mail following assessment.</p> <p>Individuals can self-refer or be referred by others involved in their support.</p>

Details of all Specific national or local scheme/intervention(s) available	<p>Interventions and support provided by Addiction Recovery Team include detox, aversion drugs such as acamprosate, relapse prevention and other coping skill strategies.</p> <p>Additional support may be provided by mutual aid groups (AA), Building Futures as listed below. An alcohol treatment</p>
	requirement is imposed where the individual's dependence on alcohol contributes to offending. A supervision requirement must be imposed.
Possible Outcomes	<p>Alcohol use is reduced or stopped and alcohol related offending is reduced. Improved ability to manage high risk-situations, ability to identify triggers and develop coping strategies.</p> <p>Improved physical and emotional health.</p>
Process for Assessment and/or inclusion in scheme/intervention	At Criminal Justice Social Work report stage. A specialist assessment may be requested by report writer to determine dependency on alcohol and required treatment.

Programme Title and Provider	Treatment: alcohol; Youth Justice

Details of all Specific national or local scheme/intervention(s) available	Young People can be required to attend alcohol treatment as part of their Community Payback Orders. This service would be provided by North Lanarkshire Integrated Addiction Services.
Possible Outcomes	The young person will address their addiction which would hopefully assist in the reduction of offending and them to gaining a more stable lifestyle.
Process for Assessment and/or inclusion in scheme/intervention	Through the Criminal Justice Social Work Report, where the specific need is identified in the Criminal Justice Social Work Report.

DRUG TREATMENT AND TESTING ORDER (DTTO)

Interventions suitable for	Males and females aged 16 or over who have a serious drug problem which is linked to their offending.
Programme Title and Provider	Drug Treatment and Testing Order (DTTO)
Details of all Specific national or local scheme/intervention(s) available	<p>Treatment and support provided by social worker, addiction nurse and addiction worker includes substitute prescribing, detox, psychosocial interventions to support behaviour change, harm reduction advice, BBV testing, and support with any immediate needs i.e. benefits, housing and health.</p> <p>The individual may be linked to third sector support providers such as Building Futures. Males and females aged 16 or over who have a serious drug problem which is linked to their offending.</p>
Possible Outcomes	Substance use is reduced or stopped and drug related offending decreased. Improved ability to manage high risk-situations, ability to identify triggers and develop coping strategies. Improved physical and emotional health.
Process for Assessment and/or inclusion in scheme/intervention	Drug Treatment and Testing Order assessment may be initiated by court or Criminal Justice Social Work report writer. The individual requires to be assessed by Drug Treatment and Testing Order social worker and nurse/addiction worker from Addiction Recovery Team.

Interventions suitable for	Any young people over aged 16 years who meet the assessed criteria
Programme Title and Provider	Drug Treatment and Testing Order (DTTO); Youth Justice
Details of all Specific national or local scheme/intervention(s) available	Drug Treatment and Testing Order available for any young people over aged 16 years who meet the assessed criteria.
Possible Outcomes	The young person will be given every opportunity to address their use of drugs which should then assist in the reduction of offending and assisting the young person to gain a more stable lifestyle.

<p>Process for Assessment and/or inclusion in scheme/intervention</p>	<p>The Court of the Social Worker, through the Criminal Justice Social Work Report can refer a young person to the Drug Treatment and Testing Order service.</p> <p>The service could then consider suitability for further assessment and recommend to the Court a deferment for 4 weeks for screening and more evidence. This could include an assessment by a health professional.</p>
