#### COMMUNITY PAYBACK ORDER: PROGRAMME

<b>Interventions suitable for</b>	Males and females, aged 16 years+
<b>Programme Title and Provider</b>	Up2U
<b>Details of all Specific national or local scheme/intervention(s) available</b>	Domestic abuse programme, male/female, 16+ used for Supervised Bail, Diversion, Supervision.
<b>Possible Outcomes</b>	The programme utilises established risk assessments tools used by Criminal Justice Social Workers to determine future risk and perpetrators needs in relation to the level of intervention they will require to reduce reoffending e.g. SARA (Spousal Assault Risk Assessment). It also includes modules relating to stalking which has the potential to fit in with recent Stalking Assessment and Management (SAM) training completed by social workers in the service.

<b>Process for Assessment and/or inclusion in scheme/intervention</b>	All domestic abuse cases will be assessed during the initial phase of any community order once imposed.

<b>Interventions suitable for</b>	Males and females aged 16 years+
<b>Programme Title and Provider</b>	Citizenship Modules (currently suspended)
<b>Details of all Specific national or local scheme/intervention(s) available</b>	Local 12 week generic citizenship modules which can be accessed by male/female, aged 16+ used for Supervised Bail, Diversion, Supervision.
<b>Possible Outcomes</b>	Provide opportunities to develop better understanding of community responsibility.
<b>Process for Assessment and/or inclusion in scheme/intervention</b>	Assessed through statutory review process post sentence.

**COMMUNITY PAYBACK ORDER: TREATMENT: MENTAL HEALTH**

<b>Interventions suitable for</b>	As per national guidance.
<b>Programme Title and Provider</b>	Treatment: mental health
<b>Details of all Specific national or local scheme/intervention(s) available</b>	Dependent on individual need.
<b>Possible Outcomes</b>	Support engagement with mental health service where this is a risk factor/indicator.
<b>Process for Assessment and/or inclusion in scheme/intervention</b>	Criminal Justice Social Work Reports /NHS assessment.

**COMMUNITY PAYBACK ORDER: TREATMENT: DRUGS**

<b>Interventions suitable for</b>	As per national guidance.
<b>Programme Title and Provider</b>	<b>Treatment: drugs</b>
<b>Details of all Specific national or local scheme/intervention(s) available</b>	Work in partnership with local Alcohol and Drugs Partnerships.
<b>Possible Outcomes</b>	Reduce propensity to offend whilst under the influence of drugs where dependence exists.
<b>Process for Assessment and/or inclusion in scheme/intervention</b>	Criminal Justice Social Work Reports /NHS.

**COMMUNITY PAYBACK ORDER: TREATMENT: ALCOHOL**

<b>Interventions suitable for</b>	As per national guidance
<b>Programme Title and Provider</b>	Treatment: alcohol
<b>Details of all Specific national or local scheme/intervention(s) available</b>	Work in partnership with local Alcohol and Drugs Partnerships.
<b>Possible Outcomes</b>	Reduce propensity for alcohol related offending where dependency exists
<b>Process for Assessment and/or inclusion in scheme/intervention</b>	Criminal Justice Social Work Reports /NHS.

**DRUG TREATMENT AND TESTING ORDER (DTTO)**

<b>Interventions suitable for</b>	As per national guidance.
<b>Programme Title and Provider</b>	Drug Treatment and Testing Order (DTTO)
<b>Details of all Specific national or local scheme/intervention(s) available</b>	In-house intense drug treatment via a multi agency specialist team.
<b>Possible Outcomes</b>	Reduce propensity for drug offending and stabilize drug use. Drug testing to support compliance.
<b>Process for Assessment and/or inclusion in scheme/intervention</b>	Criminal Justice Social Work Reports /Drug Treatment and Testing Order assessment.

**STRUCTURED DEFERRED SENTENCE**

<b>Interventions suitable for</b>	Males / females aged 16+ who require a limited medium to low risk intervention.
<b>Programme Title and Provider</b>	Structured Deferred Sentence
<b>Details of all Specific national or local scheme/intervention(s) available</b>	Individual case management plan, short term intervention 3-6 months, supplementary report provided to court.
<b>Possible Outcomes</b>	Addressing criminogenic need at the earliest opportunity.
<b>Process for Assessment and/or inclusion in scheme/intervention</b>	Via Criminal Justice Social Work Report.

<b>Interventions suitable for</b>	All service users
<b>Programme Title and Provider</b>	West Lothian Included-Wise Group
<b>Details of all Specific national or local scheme/intervention(s) available</b>	A range of online resources suitable for all with a focus of desistance
<b>Possible Outcomes</b>	Mental wellbeing support / soft skills
<b>Process for Assessment and/or inclusion in scheme/intervention</b>	Accessed via "Other Activity"
